(1) Applies to **Regular or Regular Firm Membership**. Initiation Fee is paid in (2) installments - (1) \$8,750.00 at the time of Application; (2) \$8,750.00 on first anniversary date.

(2) **Young Business Person**. Membership period is limited to 10 years or to age forty (40), whichever comes first, at which time membership terminates. Member may continue upon conversion to Proprietary Membership with Initiation Fee from **YBP** Membership credited toward Proprietary Membership Initiation Fee.

(3) **JPP-Legacy** Applicant must be between 21 and 29 years old and the child of a current Proprietary Members in good standing and who has been a Proprietary Member for at least 3 years. Must convert to other category or resign at age 30 or within 30 days of termination of the Proprietary parent's membership. If converts to YBP or Regular, the initiation fee shall be credited towards that initiation fee.
