(2) Young Business Person. Membership period is limited to 10 years or to **age forty (40)**, whichever comes first, at which time membership terminates. Member may continue upon conversion to Proprietary Membership with Initiation Fee from **YBP** Membership credited toward Proprietary Membership Initiation Fee.

(3) Associate Non-Equity Membership. Membership terminates after (3) years. Member may convert to Proprietary Membership anytime prior thereto, with Initiation Fee from **ANE** Membership credited towards Proprietary Membership Initiation Fee.
